## Tour #2 Summary Report

### Tour Objectives:

1. *To provide, through community outreach and events, information that will save lives and enable Canadians to make informed decisions about the experimental nature of the COVID 19 vaccination program, the failure of the vaccine to guard against contraction of the Covid virus, and the failure of the vaccine to prevent transmission.*
2. *To educate those who consented to participate in the vaccine experiment about the now known dangers associated with the COVID 19 vaccine. This includes a review of the court ordered release of the [Pfizer documents](#) identifying adverse reactions and other hidden information detailing the known harms associated with the vaccine.*
3. *Educate and inform Canadians about the signs and symptoms of injury and illness related to the COVID 19 vaccination and how to report adverse reactions.*
4. *Research includes data collection of those injured by the vaccine and acquiring individual testimonials to provide a more comprehensive understanding of the degree and scope of harm associated with the Canadian COVID-19 vaccination program on Canadians of all ages.*

## Tour # 2: October 19, 2022 – October 31, 2022

*Justice for the Vaccinated*, Tour #2, commenced on October 19, 2022. Headlining this tour was Dr. Stephen Malthouse and Dr. Charles Hoffe and Kari Simpson. Events were scheduled to be held in 7 BC locations and 3 events in Alberta. The BC event locations included Castlegar, Creston, Cranbrook, Dawson Creek, Sorrento, Vernon, and Penticton. Tour #2, expanding its reach into Alberta, held events in Red Deer, Grand Prairie, Edmonton, and Calgary.

There was some hesitancy initially about Alberta, and if the level of citizen support for the Doctors on Tour team was significant enough to justify the events in Alberta. That hesitancy was dispelled quickly with the enthusiastic social media response to the publication of our event schedule. Another situation arose when we travelled to the location of the **United Conservative Party's** AGM that confirmed our decision to include Alberta was the right one.

UPC AGM - Our intention was to use the conference centre where the AGM was being held as a backdrop to create a quick [video](#) update on the tour and to thank newly appointed Premier Danielle Smith for her courageous leadership on protecting the rights of Albertans to not be punished for refusing to be vaccinated and to reinstate unvaccinated healthcare workers. While we were setting up to shoot the video, people started coming out of the building where the AGM was being held. One woman crying out, "It's true, the bus is here!" A crowd gathered, and next thing the doctors were being ushered into a room where 800 AGM participants were gathered. This impromptu stop afforded several Alberta MLAs to be informed about vaccine injury and certainly expanded the citizen support base for the tour.

We were not surprised that all 3 events in Alberta were filled with grateful audiences.



Alberta MLA Shane Getson joined the Edmonton event. Mr. Getson shared his vaccine injury story and is mounting a very public campaign on behalf of the vaccine injured in Alberta. The J4V research will be shared with Mr. Getson and form a large part of his report to the Alberta legislature. This information will also be presented to the National Citizens Inquiry.

During the events, several vaccine-injured people shared their stories. As a team we learned that harmed individuals were being subjected to cruel assessments of being labelled 'crazy' for thinking their symptoms were related to a vaccine injury. In other cases, like Joelle from Red Deer, the failure of the system to help her as doctors have not been trained to treat vaccine injured people. How do you treat someone with acute kidney failure due to the vaccine if you have been misled by your professional regulatory colleges that the vaccines are 'safe'? In Joelle's case you subject her to 8 operations in 7 months and try to get her a new kidney only to be told that she does not qualify to be added to the transplant list because she isn't fully vaccinated.



We were also privileged to have local doctors as guest speakers. These doctors



included Dr. William Makis, a nuclear medicine physician, who is currently investigating the sudden and unexpected deaths of over 80 young Canadian doctors who have died since the roll out of the COVID 19 vaccine spoke at the Edmonton event. Dr. Eric Payne, Paediatric Neurologist and researcher, spoke at the Calgary event about the release of the troubling Pfizer documents and the current studies on how long the dangerous COVID spike proteins continue to manufacture themselves in the human body after being vaccinated.

All events on this tour were highly successful. Most venues were filled to legal capacity, in some cases standing room only. Audience participation indicates that an increasing number of vaccinated individuals are attending. Estimates suggest a slight majority of people attending have received the COVID 19 vaccination and are concerned for their health. Symptoms most often reported include fatigue, loss of strength, heart palpitations, growths, rashes, paralysis, swelling, death, bleeding nose or bleeding from other body outlet (penis, heavy menstrual bleed...), late term miscarriages, myocarditis, pericarditis, kidney failure and extended recovery period from flu and colds. Numerous concerns raised about fertility from young people.



## “The Bus”

The Bus has become iconic. It signifies a message of hope, boldness and tells the real story about the pain and suffering Canadians are experiencing as a result of being used in an experiment, an experiment with deadly consequences in some cases.



The Bus is a magnet, it draws people. There are so many stories to tell about the encounters we experience as a result of the bus being parked somewhere visible. Here are just a few. A nurse approached us as we were packing up outside our hotel. She works in the camps where access is typically by air. She thanked us for educating the public and then informed us about the vaccine injuries she is seeing, including the recent extraction of two camp workers who had to be flown out due to be paralyzed from the waist down after getting vaccinated. She also informed us that public health officials, seeing so many arms swollen to the size of a grapefruit after being injected by the COVID shot, told the frontline nurses working with the public not to view this as an “injury” by simply refer to it as “COVID Arm.”

A few minutes later we parked outside a mall where a COVID vaccination clinic was being held. Here is the [link](#) to an interview with a woman we met in the parking lot who wanted to remain anonymous but wanted to share about her life after getting the Covid 19 vaccine. This woman overheard one of the J4V team members talking about vaccine injured as she was making her way into the mall. She stopped and turned towards us and said loudly, “that’s me!”

Every time the bus stopped, whether it be for a meeting, a visit to a mall where a Covid clinic was being held or a hotel stop for the night people came, took pictures, and shared their stories.



The bus also broadcasts a strong message that we are determined to give people the information they need to make informed decisions about the vaccine. “Castanet” is an online news distributor that facilitates Kelowna, Vernon, Penticton, and surrounding BC communities. The Castanet reporters had done a number of “hit” pieces on those trying to bring a more factual account of what is transpiring as a result of the vaccination program and how millions of tax-payer dollars were being paid to news services to advertise and promote the government approved narrative.

The J4V team was asked to meet with and speak to the Castanet staff by local community leaders. The doctors agreed, and as time permitted it was decided that the tour bus would make an additional stop. As the bus pulled up in front of the Castanet offices, the J4V team watched in disbelief—and amusement—as the Castanet staff started to pull down the blinds and lock doors. A few cameras were clearly peeking out from behind the blinds and recording the arrival of the J4V bus.

The J4V team called the Castanet office to see if the editor or reporters wanted to meet and be informed about the tour, the stories of the injured, the dangers associated with the vaccine and the research we were acquiring. The answer was “no”. The team then knocked on the door to the office, no one responded. Regrettably, profits and greed have compromised journalistic integrity. This factor alone has contributed to Canadians being lied to, conned, and deceived about the safety of this experimental “vaccine.” Expert voices have been silenced and vilified. Canadians have a right to information, even when it contradicts the government narrative. Canadians are now paying the price with vaccine related injuries that were 100% preventable and many continue to be in jeopardy due to the failure of public health officials to admit they were wrong and warn Canadians about the potential risks they face from blood clots, strokes, heart attacks, paralysis...

## More Opportunities

In addition to the events the J4V team creates opportunities to help inform other healthcare professionals. As an example, while in the Okanogan the doctors took the opportunity to visit two different pharmacies. Both pharmacists welcomed the information packages specifically created for doctors and pharmacists.

Most concerning was this pharmacist was unaware of the court ordered release of the Pfizer documents that expose the cover-up of known harms associated with the vaccine. The videotaped exchange with one of the pharmacists has been used as a training tool to help those distributing this educational material to more pharmacist. (Video linked [here](#), has been viewed more 15,000 times on Facebook alone.)

Another opportunity afforded Dr. Malthouse and Kari Simpson to educate several people waiting at a “pop-up” clinic in a Nelson mall. The information



brochures helped to educate people about the increased dangers associated with the boosters by providing brochures and engaging in conversations.

## Online Audiences and Tour Reach

Technology provides an enormous benefit in the expansion of audience reach. Every event is both livestreamed on Facebook and then shared on Twitter, Instagram, TikTok and other platforms. The events are also video recorded, edited and posted to numerous websites. The livestreamed recording is available instantaneously. People who have attended the events can share the live-streamed version with friends and family members by simply “sharing” the Facebook page. Attendees to the events like to share their local event, so we post every event on social media but also the websites associated with the tour.

J4V tour 1 reached over 16,000 views, tour #2 increased viewership of the events to over 65,000 (still climbing). All social media views, include the media produced involving the tour, media that includes not only the events but TikTok, promos, points of interests, people we meet on tour and fun moments. This media viewership exceeds 125,000 views. In addition to our digital platforms, we received additional audience views from various media including Rebel News. ## What the J4V team learned? Kari Simpson sums it up:

“At first, we believed that the success of the Justice for the Vaccinated tour was embedded in the cruel irony that our ‘success’ is measured by identifying the extent of harm, pain and suffering that kind, trusting Canadians are experiencing. Canadians who believed what they were being told by public health officials and politicians. In other cases, Canadians who were coerced into injecting an experimental concoction into their bodies so they could remain employed and provide for their families, visit family members in hospitals, or care facilities, or travel. It is a shameful and sad reality that exposing victims—their pain, suffering and deaths—are the required tools for social change and the required proof needed to convince politicians that their reliance on

incompetent public health officials and money-making corrupt corporations resulted in this vast assault on the Canadian people.

While the tours thus far have exceeded our expectations in identifying the injured and helping them regain their power through education, support, and research, we have also learned that a vaccine injury does not only affect the victim, but their entire family suffers. Family members now must care for the injured person and cope with everyday life tasks like caring for children, being responsible for paying all the bills, grocery shopping etc.

We learned that there is more vaccine injured people than we first anticipated. We learned that the vaccine injured, especially those suffering with heart related issues, are afraid to go to a doctor for fear of losing their jobs. We learned that our efforts to educate and give voice to the injured has resulted in more and more people questioning the conduct of the government and public health agencies. We learned that as more and more people become aware that they are vaccine injured, or are at risk for a heart attack, stroke or other vaccine induced disabling injury that a new outrage is gaining momentum and being directed to those who deceived good Canadians into getting vaccinated. We learned the reasons why people were refusing to get their boosters; “Shot didn’t work, got COVID”, “My body didn’t feel right after getting the vaccine”, “My period wouldn’t stop, lost so much blood”, “I feel like I am going to have a heart attack”, “I blew my nose after getting the second shot and a long stringy blood clot came out, my nose wouldn’t stop bleeding” ...

Most importantly we learned that by educating people we are **saving lives** and **giving hope** to those harmed. It is a privilege to be a part of this amazing team and an honour to help the thousands of Canadians we have touched and the thousands more to come. This project, the team of doctors, the “Bus” and the road crew, is truly an **essential service.**”

## Tour #3

The “Doctors on Tour” and organizing team have agreed to one more short tour in 2022, weather permitting. Tour #3 will travel into the Saskatchewan and Alberta communities that were missed on Tour #2. The “Doctors on Tour” bus will visit the Grey Cup! More and more communities are asking for the tour. Tour #3 is scheduled to commence on November 19 – Nov 26, 2022. (Report pending.)
